MR & MISS PRIDE WINSTON-SALEM PAGEANT DETAILS

Participants in the Mr. & Miss Pride Winston-Salem (Pride WS) pageant must be a resident of North Carolina, live within a 100-mile radius of zip code 27101 – Winston-Salem, and cannot currently hold another “Pride” title without prior written consent from the President of the Pride Winston-Salem Board. Eligible contestants should identify with the LGBT+ community – as this title will be won by someone who will represent the community.

Any entertainer who presents a male persona or illusion on stage (biological male, pre or post-op male or male impersonator) may compete for the title of Mr. Pride Winston-Salem.

Any entertainer who presents a female persona or illusion on stage (biological female, pre or post-op female or female impersonator) may compete for the title of Miss Pride Winston-Salem.

REGISTRATION

Contestants competing for Mr. & Miss Pride Winston-Salem are required to attend registration the day of the pageant. Registration will be from **5pm – 6pm @ Village Inn – Hotel & Event Center**. During this time our Pride Winston-Salem representatives will be introduced, all rules and responsibilities will be reviewed with contestants, contestants can pay any remaining registration and/or dancer fees, fill out & turn in paperwork, and contestants will draw their pageant numbers. Each contestant is allowed only one (1) Dresser & the Dancer fee is half the general admission cost per dancer.

(Interview Category Will Begin – Directly Following Registration @ 6:15pm)

There is a \$40.00 entry fee up to the Sunday **before** the pageant. Afterwards – it is a \$50.00 fee.

HOW TO PAY YOUR REGISTRATION FEE

Pre-Registration – go to our website pridews.org/pageant and look for the PayPal link for secure credit card processing. Contestants may also pre-register at a Pride Winston-Salem event and one of our representatives will be happy to process your payment in the form of CASH or CREDIT CARD.

At the door – we will take CASH or CREDIT CARD at the full registration fee pricing.

(REGISTRATION FEES ARE NON-REFUNDABLE)





REQUIREMENTS AND EXPECTATIONS OF TITLEHOLDERS

- Represents Pride Winston-Salem effectively and responsibly, while adhering to the bylaws of Pride Winston-Salem. Titleholders are NOT allowed to hold nor compete for another “Pride” title while reigning for Pride Winston-Salem without written consent and approval from the Executive Board of Pride Winston-Salem.
- Titleholders are NOT to participate in gossip, slander, or disparaging conversations of any kind during their reign. No Exceptions! This also includes ALL social media platforms.
- Attend and perform at the Pride WS kickoff party, festival, and after party following the festival. Titleholders will also Ride in the Pride WS Parade the morning of the festival.
- Attend no less than (5) Pride Winston-Salem functions and fundraisers during your reign or at the specific request of the Board of Directors.
- Stay in communication with the board President & Vice- President during the year. Titleholders will be provided a Pride Winston-Salem email account, be included in applicable distribution lists, invited to attend Board meetings as an advisory member (non-voting) throughout their reign, & will be given the option to become a voting member (attending as many meetings as possible is required).
- Promote Pride Winston-Salem on social media including our Mr. & Miss Pride Winston-Salem Facebook page, distributing materials at Pride Winston-Salem functions, & more.
- Represent and promote Pride Winston-Salem at LGBTQ+ community events & Prides. Titleholders must attend these events in their title’s persona and also execute any other tasks that may be required of them.
- Titleholders will be leading personnel in charge of planning the Mr. & Miss Pride Winston-Salem Pageant for the following year during their reign.
- Titleholders will be eligible to run for the title of Mr. & Miss Pride Winston-Salem (2) years after their reign with the approval of the President, Vice-President, and Board of the Pride Winston-Salem.
- Pride Winston-Salem will arrange a photoshoot for the titleholders up to (90) days after crowning. Titleholders are required to appear in persona with sash and crown.



BREACH OF AGREEMENT

Titleholder will be considered in breach of agreement if any and/or all **REQUIREMENTS AND EXPECTATIONS** are not met as determined by the Board of Directors of Pride Winston-Salem.

Breach of agreement will result in the following:

- Revocation of Title
- Cancellation of future bookings, appearances, and fees stated in this contract
- Return of all prizes won. (If any prize is damaged, replacement will be required)

Pride Winston-Salem reserves the right to take action if it is determined that a Titleholder is in BREACH of AGREEMENT.

PRIZE PACKAGE FOR PAGEANT WINNERS

Mr. Pride Winston-Salem

- Sash and Crown
- \$ 175 cash the night of winning the title
- \$ 175 cash the night of title step-down
- {*Based on overall quality of titleholder’s reign}
- \$ 75 Stipend
- {*After Mid-Reign (6 months) titleholder review - conducted by the PrideWS Board}

Miss Pride Winston-Salem

- Sash and Crown
- \$ 175 cash the night of winning the title
- \$ 175 cash the night of title step-down
- {*Based on overall quality of titleholder’s reign}
- \$ 75 Stipend
- {*After Mid-Reign (6 months) titleholder review - conducted by the PrideWS Board}

****Pride Winston-Salem’s Board will evaluate both Mr. & Miss 6 months into their reign – to assess whether their work, performances, completed duties, visibility, and more – qualifies them to receive the \$75 Stipend. Pride Winston-Salem’s Board will also make the final decision concerning both Mr. & Miss \$175 step down fee – based on their overall reign, work ethic, performances, visibility, completed duties, volunteer work, & more prior to end of titleholders reign. If for any reason a titleholder does not fulfill all that is required of them, the board reserves the right to take proper measure & decide on final payout.*



CATEGORIES AND SCORING FOR MR. & MISS PRIDE WINSTON-SALEM

***INTERVIEW**

The main focus of this interview will be to determine if the contestant is a suitable and worthy representative of Pride WS, similar to interviewing for a job. Contestants will be interviewed by five (5) judges, along with the **reigning titleholder** in their division. Each judge will ask at least one question, and the contestant will be given the opportunity to answer. Any judge may also interject with a follow-up question. Time limit – will be a minimum of 5 minutes (Not to exceed 7 minutes).

Interview Scoring will be based on:

- Content (Answers) -Substantial, relevant, appropriate answers.
- Communication (Personality) -Effective gestures, voice tone, facial expressions.
- Appearance- No dress code or standard. Contestant discretion.
- Overall Impression-Rated recommendation.

***PRIDE WS PRESENTATION**

This category is open to each contestant's interpretation. Presentation is a chance for contestants to present "what makes them proud" or "their idea of what pride is." Be Creative! It may be delivered in the form of a clothing/modeling category, as a "mini-talent", or any other creative performance or form of pride. Five (5) BONUS POINTS will also be awarded to contestants who VISUALLY include an aspect of Winston-Salem as a MAJOR part of their presentation (i.e. landmarks, historical facts/events/things unique to Winston-Salem). Props are allowed, but set-up time and tear down time should be limited to one (1) minute each {set up - 1 minute and break down – 1 minute}. The set up and break down time is not applied to your overall time limit for the category. Contestants must provide their own music. There will be a brief section allowed to the contestants to do a speech to introduce themselves to the judges, and expand on their presentation. **Presentation cannot exceed three (3) minutes Overall (with speech included)**. Violating the time requirements will result in an automatic five (5) point deduction from each judge's score.



Presentation Scoring will be based on:

- Content (Technical) -Substance, relevance, relates subject to Pride.
- Delivery & Speech (Artistic) -Creativity, stage presence, execution, voice tone.
- Appearance-Costuming, hair/makeup, accessories.
- Overall Impression-Rated recommendation.

***QUESTION AND ANSWER (ONSTAGE QUESTION)**

Q&A will be held as part of the Presentation segment but is judged separately. Contestants will be given an opportunity to speak before the emcee proceeds with Q&A. Contestants will select a predetermined question approved by the board of directors of Pride Winston-Salem, the emcee will then read the question out loud twice to the contestant, & the contestant will then be given the opportunity to answer the question for the judges and audience.

Q&A Scoring will be based on:

- Content -Substantial, relevant, appropriate answer.
- Communication-Effective gestures, voice tone, facial expressions.
- Overall Impression-Rated recommendation.



***TALENT**

Mr. & Miss Pride Winston-Salem Talent may not exceed seven (7) minutes. Contestants will be allowed a two (2) minute set up and two minute (2) break down time. Contestants must provide their own music. Violating the time limits will result in an automatic five (5) point deduction from each judge's score. Props are allowed, but space will be limited to store them and set them up on stage. Fire, water, loose glitter or any other potentially dangerous or damaging substance is **NOT** allowed. Contestants are allowed to have "DANCERS" or others in their talents. Dancers and other individuals are **NOT** allowed in the contestants dressing area until 2 talents before. Violating this rule will result in an automatic five (5) point deduction from your total talent score.

Talent Scoring is based on:

- Entertainment Value-Impact of talent on judges and audience.
- Stage Presence/Performance – Comfort performing/ability and execution.
- Costuming/Appearance-Creativity, construction/appropriate to talent.
- Overall Impression-Rated recommendation.

Scoring Breakdown

Scoring will be based off the USofA style scoring system. This is a ranking system.

In the event of a tie, judges will choose the highest scoring talent. If there is a tie in talent, judges will then default to the highest scoring interview. In the event of a tie in interview, judges will default to the highest scoring onstage question. In the event of a tie in onstage question, judges will then default to the highest scoring presentation. In the event of a tie in presentation, a new onstage question will be chosen by the judges and judges will then rank contestants based on the new question.
